Due to the increased costs of mailing, tests which are not claimed at the Awards Booth within 1 hour of the end of the show will NOT be mailed to competitors. To receive your test, you must submit a self addressed stamped envelope to the TEV Show Office .

Recommendations for Participants at Equine Events

CDFA Animal Health Officials are continually monitoring for EHV-1 cases. CDFA reminds horse owners traveling with horses to participate in an equine event, that there is always disease risk when horses of unknown health status are commingled for a show or competition. CDFA strongly recommends that horse owners practice proper biosecurity when attending an equine event. Compliance with basic biosecurity practices is an important factor in reducing risk of exposure to all contagious equine diseases. Basic biosecurity measures to follow to decrease potential disease spread at equine events include:

- Limit horse-to-horse contact
- Limit horse-to-human-to-horse contact
- Avoid use of communal water sources
- Avoid sharing of equipment unless thoroughly cleaned and disinfected between uses
- Monitor your horse for clinical signs of disease and report any temperature over 102°F to a veterinarian



 The facility will be on the right just past Via Abril before Calle de Dietel you will see signs for
 Kathleen Elliott Training and Kats Ranch.

(note: this route is winding roads with hills and no passing)

Alternate Route

From 1-15 Exit Clinton Keith Road and travel west approximately 4 miles, At first STOP SIGN Turn Right on Avenida La Cresta then turn right again to stay on Avenida La Cresta. Go just under 6 miles to Gallop Lane turn right DO NOT continue on Ave La Cresta - Gallop Lane will turn into Calle Pino at some point and then into Harkey). At next STOP SIGN turn right onto Tenaja Road. Continue for approximately 3.5 miles to Calle de Dietel turn right (just past Via Abril) you will see signs for Kathleen Elliott Training and Kats Ranch.

The Patricia Ommert Western Dressage Perpetual Trophy – Awarded to the overall Highest score

(%) by an Open rider in a Western Class at a rated show.

<u>Versatility Award</u> – Awarded to the Highest scoring (%) Horse/rider combo showing both English and Western Schooling Show Series.

High Point Qualifications for All levels – Intro through Grand Prix – Traditional and Western:

- Minimum classes to be ridden 3 at Intro through Third Level; 2 at Fourth level and above
- Minimum score for Year End awards, 55.000%
- Two tests per day/show will count. The highest two scores to be used.
- Qualifying period October 1 to September 30 yearly
- > Points earned: First place = 5 points, Second place = 3 points, Third place = 1 point

To be eligible for year-end awards, you must do one of the following:

- Be a TEV chapter sponsor
- OR Volunteer a minimum of 4 hours per horse/rider combo. Volunteer hours may be assigned to horse/rider combo of choice in Rated or Schooling show. Volunteer hours may be earned by 1) Working at any TEV show (rated or schooling (Show set-up and tear-down worth double hours!) 2) Serving on a committee; 3) Helping with a TEV educational event
- **OR** pay a nomination fee per horse/rider combo in current year. TEV chapter member \$25, non TEV chapter member \$35.

RULES AND GENERAL INFORMATION

1. EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

2. All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.

3. Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.

4. The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries and cancel award prizes without claims for damages; to cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges.

5. Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees.

6. Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation.

7. In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided. All exhibitors and their agents are responsible for the proper disposal of this waste.

8. No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform.

9. It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitable presented to appear before an audience.

10. Life, Senior active and Junior active CDS Members shall be eligible to participate, A non-member may participate as a rider, owner, lessee, or agent upon payment of a \$25 CDS non-member fee. Participants in the following classes are exempted from the requirements of this rule: USDF introductory level tests, pas de deux, quadrille and Opportunity classes

11. ENTRY PROCEDURE: Entries must be made on an official entry form or photocopy of same and must be filled out completely,

including all classes entered, <u>all signatures</u>, (no <u>dittos</u>), organization membership numbers and fees. Please include a photocopy of current CDS membership card for rider and owner. Amateurs must provide a copy of their USEF Amateur card or proof of application for an Amateur card. An Internet search *will* be done for entries missing any of the required membership photocopies at a charge of \$25. Entries are accepted on a first-come, first served basis until classes are filled. Entries received after the closing date will be accepted only if the schedule permits. Each late entry that has been accepted shall be assessed a late fee of \$50. Changes to entries (\$25 per class) after the closing date will be at the sole discretion of the show management. No telephone entries will be accepted. All entries must be completed and RECEIVED by the closing date with check or credit card information . PRIOR TO THE CLOSING DATE, entries may be emailed to jessicaendresen@yahoo.com. A 5% handling fee for credit card payments will be added. Payment in full or an open check or credit card information must accompany the entry. Mail completed entries to: Jessica Endresen, 15301 Alvarado St., Lake Elsinore, CA 92530

12. AMATEURS AND JUNIORS: Amateurs are defined by the rules and specifications of the current USEF Rule Book. All riders entering the Amateur classes must possess or have applied for an USEF Amateur Card prior to riding in the class. All riders in Amateur Divisions must present an USEF Amateur Card by the closing date or they will be entered in the Open Division. Cards may be applied for at the show office. Individuals are eligible as Juniors until the end of the calendar year in which they will be 18 years of age. Individuals are eligible as Young Riders from the beginning of the calendar year in which they reach 11 years of age. Competitors will compete as Adults from the beginning of the calendar year in which they reach the age of 22. Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22.

13. REFUNDS: All fees, less a \$30 administrative fee, will be returned if horse is scratched before the Closing Date. THEREAFTER NO REFUNDS FOR ANY REASON.

14. RETURNED CHECKS: Checks returned by the bank for any reason are regarded as a most serious offense and will be handled according to the following procedure: A 10% penalty (minimum \$25.00) will be assessed for each returned check. Credit cards that do not go through will incur a penalty of at least \$10 for each occurrence.

15. ARENA: Show arena is 20 X 60 meters unless othewise specified. Footing consists of sand mixed with dirt and textile footing. Only those horses registered with the show are permitted use of the show facilities, warm-up arena and show arena. All horses in the warm-up arena must wear their competition numbers. Lunging is allowed in specific areas only and upon receiving permission of the ring steward.

RULES AND GENERAL INFORMATION continued

16. STABLING, GROUNDS FEE: Stalls may consist of fully covered mare motel stalls 12x24 in size with stallion wire between the stalls, box stalls 12x16 or box stalls 12x12. No tack stalls will be available. Stalls are only available on a first come - first entered basis at a cost of \$140 (Friday-Sun.) Grooming stalls and tack stalls will not be available for this show. It is recommended that those wishing to be stabled together, indicate their stable mates on the entry. Grounds fee of \$50 per show day applies, if not stabled. Please let us know if your horse lives at Kathleen's Stable permanently.

17. BEDDING and FEED: Shavings and hay may be ordered on your entry or by emailing jessicaendresen@yshoo.vom. No straw allowed.

18. RV PARKING: Contact Kathleen Elliott, 951-288-0521, katshorse@gmail.com

19. SHOW STATUS: In the event of inclement weather, natural or other disasters prior to the show, it is the competitor's responsibility to contact management as to the show status - please call 951-757-2112. IN THE EVENT OF UNEXPECTED TRAFFIC DELAYS, it is the rider's responsibility to TEXT show management (951-757-2112) a minimum of 1 hour prior to the start of the class. Please note that if a competitor is a NO-SHOW for ANY class, the rider forfeits his/her subsequent class reservation(s) and said slot may be given to another rider.

20. DOGS: Dogs must be on a leash. All animals should be managed so as to not disturb the competitors.

21. SCORED TEST: Tests will be distributed to riders, or their authorized representative, after the results have been finalized and awards presented. Scores will be posted when available and will be available at www.foxvillage.com..

22. STALLIONS: Stallions must be in a stall or remain in the trailer unless being managed by a qualified person.

23. SCHOOLING HORSES: Horses not entered in the show must be registered with the Horse Show office and will be given a number to be worn at all times when not in a stall or tied to a trailer. Appropriate stall or grounds fees (\$50.00/day) and mandatory office fees (\$79.00) must be paid. Any person(s) riding a schooling horse must have signed an official entry blank. A schooling horse may be allowed in the warm-up arena at the discretion of the ring steward.

24. RIDE TIMES: Times will be emailed & posted at www.foxvillage.com & TEV-CDS.com. It is the exhibitor's responsibility to contact show management if times are not received. Failure to enter the arena at the specified time may incur elimination.

25. HEADGEAR RULE: From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds including non-competing riders, riders on non-competing horses, and those competing in all classes and tests, including Para-Equestrian tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted. If there are questions regarding this rule or the use of protective headgear at USEF dressage competitions please contact Halley Griffin by email at hgriffin@usef.org or by phone (859)225-6918.

26. GOLF CARTS: and all other motorized vehicles require a valid driver's license to operate. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to Segway, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule

27. EQUINE VACCINATION RULE: Horses must be current with all vaccines (within 6 months of competition but at least 72 hours before competition).

CDS PONY AWARD

CDS has created a Pony Award. The high scoring pony at Training - Grand Prix (Freestyles excluded) at each CDS recognized show will receive a High Score Pony Ribbon.

The shows should:

1. Identify the high scoring pony on their CDS COVER SHEET.

2. ATTACH a copy of the USEF DRES-SAGE pony measurement card.

The CDS Central Office will send out the award to the pony rider. All pony riders should inform show management that they would like to be considered for the CDS Pony Award.

To be eligible, all ponies **<u>must</u>** have a current USEF DRESSAGE Pony Measurement Card.

If the pony is measured at a show and receives a temporary show measurement, that measurement will be good for all CDS shows during that show season.

CDS will also offer a Year End Award to the Highest Scoring Pony in Open, Amateur and Junior Divisions.

Ponies

Technical Delegates are certified to measure ponies with the USEF approved stick. Measuring must be performed by a TD, with the show veterinarian. In order to be officially measured, the pony must be entered in the competition. The owner must be a USEF member or pay a fee.

Dressage and/or DSHB competitions which offer classes or divisions limited to ponies are required to have an official measuring stick available and the TD must be on the Federation list of those approved to measure, or a licensed Steward must be present.

If classes restricted to ponies are not offered, the competitor is responsible for arranging the measurement and the cost of the on-call vet.

Adults and Juniors may show ponies in dressage. If you own a pony, read the entire section in the USEF Dressage Rules. www.usef. org.

CDS will accept temporary show measurements and the competitor may take that measurement form and use it for that show and any CDS show during the current show year. The USEF official DRESSAGE PONY measurement cards will be accepted as a valid card.

There are no courtesy, or trial measurements. Once the show officials place the stick on the pony, the measurement is final. Ponies must be re-measured annually until they reach the age of eight.

Your responsibility as a pony owner and or rider:

1. Know the rules. If you have any questions, call USEF.

2. If a pony class is offered at a show and your pony does not have a current measurement card, contact the show management to make sure they have an approved metric stick, and at the same time letting them know your pony needs to be measured prior to its class.

3. If you are in possession of a valid USEF DRESSAGE pony measurement card, then, simply enclose a copy of it with your entry.

Horse Lifetime Points & Awards Program

WDAA Horse Lifetime Points & Awards Program

The WDAA Horse Lifetime Points & Awards Program tracks points achieved by a horse throughout their Western Dressage career.

Points must be earned at WDAA recognized shows (find shows under Events on WDAA website)

Open to all horses, ponies, and mules regardless of breed, type, age, etc.

Points may be earned with more than one rider.

Owners and persons participating and/or riding a horse in the program must be current WDAA members in good standing.

Points awarded at all WD levels and Freestyle tests, as well as for rail classes.

WDAA World Championship Show test/classes earn triple points.

USEF shows with a USEFlicensed Western Dressage judge earn double points. Check the WD judge directory on the WDAA home page under "Important Links" to see whether your judge qualifies for double points.

Program Fees

- Horse Enrollment Fee: \$100
- Annual Recording Fee: \$50
- Test Submission Fee: \$10/test or rail class
